

## ANNEX II

### GENERAL TERMS AND CONDITIONS FOR THE REGISTRATION OF .CL DOMAIN NAMES

The following provisions constitute the general terms and conditions for the registration of .CL domain names, all of which registrars shall include in the contracts they enter with their customers.

1. CL is the country code top-level domain for the Republic of Chile. Known as NIC Chile Registry, the .CL Domain Name Registry is managed by the Department of Computer Sciences of Universidad de Chile.
2. The [Regulations for the Operation of the .CL Domain Name Registry, all Policies and Procedures](#) established for conducting the functions relating to the management and registration of domain names under .CL shall be considered to be an integral part of the contract for the registration of .CL domain names.
3. The registrant declares that:
  - a) He or she understands which characters are allowed under the .CL domain name [Syntax Policy](#);
  - b) He or she authorizes publishing the domain name information solely for purposes related to the administration of the .CL domain name registry and operation of the DNS. He or she further agrees that registration data will be provided if formally requested by a judicial or administrative authority legally authorized to present such requests. NIC Chile Registry shall store domain name information in a database, which under no circumstance shall be handed over, sold, assigned or transferred to any person or organization. Notwithstanding the foregoing, NIC Chile may provide information to third parties for academic research or development purposes, prior signing of the corresponding confidentiality agreement;
  - c) To the best of his or her knowledge, the domain name is being registered for lawful purposes, in good faith and does not infringe upon or violate the rights of third parties in any way;
  - d) The data he or she is submitting is complete and accurate, and he or she agrees to keep the information current and updated. Failure to comply with this obligation may be considered grounds for deletion of the domain name.
4. In order to register a .CL domain name, registrants shall provide the following information:
  - a) The domain name.
  - b) The address, email address, and telephone number of each contact (holder, administrative, technical and commercial contacts). Optionally, personal identification data may be included.
  - c) DNS server names and other technical data.

5. When necessary for reasons of security, stability or proper operation of the DNS, NIC Chile Registry may reserve certain domain names, which shall not be available for registration by third parties.

6. NIC Chile Registry shall publish all registered domain names on a list of "registered domain names," where they shall remain for a public review period of 30 (thirty) calendar days so that any eventual disputes may be initiated.

7. In the event that, pursuant to an arbitration award or court order issued by a competent authority, NIC Chile Registry is ordered to perform any operation, including but not limited to, changing a domain name holder, deactivating, modifying, deleting, or blocking a domain name, Universidad de Chile, its Department of Computer Sciences, NIC Chile Registry, its officers and advisers shall not incur liability of any kind.

8. It shall be the sole responsibility of the domain name holder to ensure that the registration does not affect the right to freedom of expression and information, the principles of fair competition and business ethics, as well as the rights validly acquired by third parties. NIC Chile Registry shall have no liability for the use that the registrant makes of the registered domain name.

9. Once a domain name has been deleted either voluntarily or due to non-payment, a redemption period of 30 calendar days shall apply. If the redemption fee is paid, the domain name shall be renewed for another year as from its expiration date.

10. The registrant may transfer the domain name to another registrar, unless the domain name has been blocked or is undergoing restoration.

11. Any dispute arising in connection with .CL domain names shall be governed by the provisions of the .CL Regulations and the .CL Domain Name Dispute Resolution Policy.
